- font: Times New Roman Cyr
- size -12, line spacing -1
- indention 10 mm.
- margins: left -25 mm, right -10 mm, top -20 mm, bottom -20 mm.
- tabular and graphic filling minimal. The Word graphs are required to group.

- **structure of the abstracts**: Name of the author and co-authors (maximum 3) – on the right, capital letters. Below - Name of the institution. Below double-spaced - Name of abstract in capital letters (centered, bold). Double spaced – Text. References are not required.
