## REQUIREMENTS TO THE PAPER

The abstract should be up to 4 pages (with references). Abstracts should correspond to the scientific topics of the sections and can be prepared by one or several authors.

### *Abstracts should highlight the following elements:*

- 1) formulation of the problem in general and its connection with important scientific and practical tasks;
- 2) the brief analysis of recent research and publications which launched research into the problem and which is cited by the author(s);
- 3) identification of previously unsolved parts of the problem;
- 4) formulation of the objectives or setting the task to be solved by the author(s);
- 5) the brief presentation of the main research body with new scientific outcomes substantiated;
- 6) conclusions on the research.

Manuscripts should conform to the grammatical and orthographical standards. Manuscripts will be published without additional editing or proofreading. Authors are responsible for the content of materials and spelling.

### **Manuscripts which do not comply with the above-stated requirements will be rejected**

For text processing, please use MS Word 97-2013 with expansion .doc or .docx. Page format – A4 (210mm, 297mm). Parameters of page margins: top - 2 cm, bottom - 2 cm, internal - 2,5 cm; external - 1,5 cm; mirror margins.

### ***Text layout:***

- Authors' names: semi-bold, Times New Roman, 12pt size of alignment on the right side;
- In the next line – the name of organization in semi-bold, italics, Times New Roman, 12pt size;
- Through a line - title of manuscript in semi-bold, Times New Roman, 12 pt size, centred;
- Through a line - the main text.

The main text should be typed in Times New Roman, 12 pt size, aligned across the width of the page, indentation 1 cm; single line spacing.

**Tables** are numbered on the right side of the page in italics. Titles of tables placed in the center (semi-bold). Font size for typing in the table - no more than 10 pt.

**Formulas** should be written by formula editor MS Equation (version 3.0). Equations should be numbered in parentheses to the right of the text.

**Figures** must be inserted into the manuscript in bitmap formats TIFF, BMP, JPG with resolution 300dpi. Figures should be captioned using 10 pt, Times New Roman. Figures created with MS Word tools should be grouped as one object. Captions are placed under the figures, centred, using the face type of the main text.

References should appear in italics at the end of the text without title “References”. The retreat from the text - 10 pt. References should be listed in the order of their referencing in the manuscript according to the state standard DSTU HOST 7.1:2006.

3<sup>rd</sup> line – full name of author / co-authors (italics). Alignment – on the left.

4<sup>th</sup> line – place of work. Alignment – on the left.

5<sup>th</sup> – the city and country (italics). Alignment – on the left.

6<sup>th</sup> line – e-mail of author / co-authors (italics). Alignment – on the left.

7<sup>th</sup> and 8<sup>th</sup> lines – blank lines.

from 9<sup>th</sup> line – abstract (up to 10 lines), key words (3-6 words) and text of paper (with indent 1 cm).

Alignment – on the width.

**Size:** 20000-40000 characters.

The registration fee for participation in the collective monograph is 450 UAH / 25 EUR / 30 USD.

The registration fee is used to partially cover the costs of preparation and holding of the conference and publishing of the collective monograph.

***Payment of the organization fee is carried out after approval by the editorial board.***
