Formatted in Word, font *Times New Roman* 14 pt,, 1,5 spaced, all margins 20 mm, paragraph spacing 10 mm, paper size A4. The pages are not numbered.

In-text references are included with square brackets, where the first digit is the ordinal number of the source in the reference list, and the second one after the comma is a number of the page. A reference list is to be included at the end of the paper in alphabetical order.

Indicate on the first page: 1) name, surname of the author (s), academic degree, academic title, position and place of work (at the top on the right); 2) the title of the paper spaced, in bold, center aligned, all capitals; 3) text spaced.
