While I spent most of my working years abroad, I also worked in my own country with and for people suffering of severe addictions (one year in the 80th) as well 6 years (recently) for the Hospice general / AMIG, the Geneva State Office in charge of Refugees and Migrants.

As I formally reach the "official retiring age" in 2024, I'm now operating as consultant.

Founded in 1945 –today composed by 193 Member States – The "Charter" founding document signed on 26.06.1945 in San Francisco / USA. "Peace, dignity, and equality on a healthy planet"

- Main bodies of the UN
 - o General assembly (GA) 193 Members States
 - Security Council (SC) 5 permanent members (China, France, Russia, United Kingdom and USA) and 10 non-permanent (change annually, five members elected according to geographical distribution to ensure fair representation for 2 year terms by the GA). The Presidency rotates and changes every month.

- Trusteeship Council established in 1945 to provide international supervision of 11 Trust Territories placed under the administration of 7 Member Stated to ensure that all required steps to ensure their self-government and independence. By 1994 all Territories had attained these two goals. Since November 1994 the Trusteeship Council suspended operation and under a new adopted resolution agreed to meet on occasion required (by the decision of its President, the majority of the GA or the Security Council.
- International Court of Justice ICJ based in the Hague (Netherland).
- Secretariat The Secretary-General appointed by the GA for a
 5 years mandate based on the recommendation of the SC.

The main functions of the Secretariat are:

- Planning and managing peace keeping (DPKO)
- Mediating international disputes
- Assisting with implementation of the SC sanctions
- Coordinating disaster relief across humanitarian agencies
- Promoting social and economic development
- Publishing statistics and research
- Setting the agenda for deliberating bodies of the UN
- Facilitating discussion and meetings among UN member States
- Short presentation of the "UN80 Initiative"

 It was launched by the Secretary-General in March 2025 marking the 80th anniversary. The resolution 79/318 adopted on 18.07.2025, the GA welcome the SG effort on how to transform the UN works by having a more agile, integrated and equipped agency to respond to today's complex challenges and tightening financial resources. Keys areas:
 - o Efficiencies and improvements
 - o Mandate implementation review
 - o Potential structural changes and programme realignments

The main goals are to be more:

- o efficient and cost-effective
- o responsive to crises and countries 'needs
